### IT IS HEREBY AGREED AS FOLLOWS:

1. Contestant understands that by signing this contract and the Expectation Statements that I will and am committing myself to the Otero County Fair and Rodeo Queen Program. This is to include one (1) year as the titleholder. During this entire period, I will conduct myself with in a proper lady-like manner, portray high moral standards, act with dignity, grace and ethical behavior befitting the title at all times. I understand that I will be living in the public eye for this period and will be a role model. I should always be properly attired and behave accordingly at all public events, including social media websites.

2. Inform the Committee of all social media that I use and will allow them to view my activity on these sites and will not block them from these sites. 6. Committee shall furnish a crown, buckle, sash and other awards as is feasible, but shall offer no form of financial assistance, nor assume the financial responsibility for reimbursement to contestant/titleholder for any expenses incurred during my reign. The furnished crown will be handed down (perpetual) at the end of my reign to the next year's contestant/titleholder. I understand and agree that if I lose or damage the crown that I am financially responsible to replace the damaged or lost crown with one in kind of the same monetary value.

7. I acknowledge that I am required and agree to attend all mandatory events, including but not limited to the following:

- i. Otero County Fair and Rodeo Events – all age divisions and contestants (mandatory)
  - a. Rodeos
  - b. Livestock shows
  - c. Teacher's Appreciation
  - d. Parade
- ii. Kiwanis Pancake Breakfast – Duchesses and Queens
- iii. First National Bank Popcorn Fridays
- iv. Trunk or Treat - mandatory
- v. Burning of the Bull - optional
- vi. Veterans Day Parade - optional
- vii. Christmas Parade - optional
- viii. Blanket Drive and Delivery - mandatory
- ix. Easter Egg Hunt - mandatory
- x. Independence Day Parade – split up based on who is available
- xi. Pageant Workshops, Orientation, Rehearsal, and Pageant - mandatory
- xii. Any other events as required by Committee

8. It is agreed that I agree to provide information on what I have done during my reign. This information will be used for future contacts and to ensure legitimacy of the Otero County Fair and Rodeo Queen Program.

9. It is agreed that should I fail to attend the required events or fulfill the duties of the Otero County Fair \_\_\_\_\_, bring embarrassment or negative attention

to the Committee or the Otero County Fair and Rodeo Association, that I shall be in danger of losing my title and any prizes awarded thereof. If I receive a second disciplinary action or breach of contract, I shall forfeit my title, crown, sash, and buckle to Committee immediately.

If I wish to use the above title in some form of social or other media other than the official avenues, or attend any outside function or event, I must first get approval from Committee in order to protect Committee and title. All outside media items, other than interviews shall get prior approval from Committee. This is including social media, websites, articles, and news releases.

11. It is agreed upon that there will be a pre-arranged chaperone, which is usually a Committee member, parent or guardian for all events attended. All events other than those listed above must have prior authorization from the Committee, prior to attending. After attending such events, it is agreed that there will be a report and any photos taken will be shared with the Committee to use for future program needs.

12. The decision of the Judges is **FINAL**, and no appeal will be considered with the Judges. In the event I feel the need to appeal the result of the judges, I will submit and appeal in writing and submit a check for **\$100.00** to the Pageant Director(s)/Committee no later than one hour after the conclusion of the pageant. All appeals shall be reviewed by Committee and brought to the Otero County Fair Association. Action if deemed necessary of said appeal will be determined by the Otero County Fair Association upon the recommendation of Committee.

13. Any and all appeals of disciplinary action must be filed in writing with Committee no later than one hour after disciplinary action. The appeal will be considered by Committee within ten (10) days of the appeal. All parties will be duly notified at the time and place for consideration of appeals. The decision of any disciplinary action from Committee are Final.

14. It is agreed that failure to follow this contract or conduct myself in any way not befitting the title of the Otero County Fair \_\_\_\_\_, said I will be asked to relinquish my title.

Title

If it comes to the attention of Committee that I have participated in activities that could be negative to the reputation of Committee, or title, either prior to or after the contest, I may be asked to relinquish the title and awards immediately.

15. I will also ask for prior approval before I purchase any type of materials, tack, clothing or other article of attire (chaps, vests, etc.) with the title I am representing from the Committee, I understand the title is the right of the Fair Association and is not to be used without prior authorization. If I do have anything made with the title or anything related to title I am representing, without prior approval, I will relinquish such item to the Committee for future program use, without compensation for such item.
